Sec. 1-3-2 Adjustment of Alcohol Beverage Licenses Fees.

- (a) **Statement of Purpose.** Due to the Public Health Crisis related to the COVID-19 epidemic, the Village Board of the Village of Bangor recognizes that some businesses which have been issued alcohol beverage licenses have been closed to the public in compliance with State Emergency Orders, denying those license holders the full use of such licenses. Furthermore, the Village Board recognizes that inequities have been created among such license holders in that the State Emergency Orders have closed some licensed establishments while other such licensed businesses have lawfully been authorized to remain open to the public for business given the nature of their operations, allowing the latter to

fully utilize their alcohol beverage license privileges. Due to the unique circumstances created by the COVID-19 epidemic, the Village Board finds that adjusting alcohol beverage license fees is warranted as a matter of public policy.

(b) **Adjustment of Alcohol Beverage License Fees.**

- (1) The Village Board authorizes reductions in the following alcohol beverage license fees for the licensing period of July 1, 2020 to June 30, 2021 to the fee amounts so designated; such adjusted license fees below supersede the fees established in Section 1-3-1:
 - a. Retail "Class B" Intoxicating Liquor License: \$200.00.
 - b. Class "B" Fermented Malt Beverage License: \$50.00.
- (2) The following alcohol beverage license fees for the licensing period of July 1, 2020 to June 30, 2021 shall remain unchanged as follows:
 - a. Retail "Class A" Intoxicating Liquor License: \$400.00 or fraction thereof.
 - b. Class "A" Fermented Malt Beverage License: \$100.00 or 3/4 amount for a 6-month period.
- (3) The following alcohol beverage license fees are established for the licensing period of July 1, 2021 to June 30, 2022; other alcohol beverage license fees prescribed in Section 1-3-1 remain unchanged:
 - a. Retail "Class A" Intoxicating Liquor License: \$500.00 or fraction thereof.
 - b. Retail "Class B" Intoxicating Liquor License: \$500.00 or fraction thereof.
 - c. Class "A" Fermented Malt Beverage License: \$100.00 or 3/4 amount for a 6-month period.
 - d. Class "B" Fermented Malt Beverage License: \$100.00.
